



EIR Report Reveals Plans for Metro Purple Line North **Portal**

A draft of the Metro Purple Line North Portal's Environmental Impact Report was released Friday, revealing details of the project's three potential portal locations

The California Environmental Quality Act legally requires projects to conduct EIR reports, which inform members of the public about a proposed project's significant environmental effects. The draft EIR will be made available to the public for a 45-day period, after which the Beverly Hills City Council will discuss it in a virtual meeting on September 16.

The purpose of the North Portal project is to create a second entrance and exit for the Wilshire/Rodeo Station on the north side of Wilshire Boulevard. The station was originally meant to only have one entrance, the South Portal, on the southwest corner of Wilshire Boulevard and Reeves Drive. The city, however, later proposed also adding a second entrance and exit to the north of the station to Metro.

One of the three proposed locations for a portal is to the west of North Beverly Drive. According to the EIR report, this project would be about 9,200 square feet and 165 feet north along North Beverly Drive. It would have three levels, which will include two elevators, one stairway and one escalator going up. There would be a covered canopy above the portal enclosed by a glass exterior.

The portal itself would be 12 feet tall and the adjacent sidewalk would need to be extended. According to the report, the project impacts five trees on the street four would be relocated and one would either be removed or located elsewhere off the project. Additionally, three on-street parking spaces - on the east of Beverly Drive – would be removed.

According to the EIR report, the configuration of the street would have one through lane and one shared through-right turn lane. The report states that two southbound and northbound travel lanes would be maintained

The second proposed portal location is at the Canon Drive Staging Yard, which would use the land to create a half-portal. It would be located on the northeast corner of Canon Drive and Wilshire Boulevard and be around 3,800 square feet.

According to the EIR report, it would have three levels with two elevators, one stairway and one escalator going up. Details of this project are similar to the proposed portal on North Beverly Drive, except that it would include public restrooms with two separate stalls and rooms at street level

It could also add a second escalator, which would require around 900 more square feet. The adjacent sidewalk would not need to be extended and there would be no traffic lane closures

The third proposed portal is the Canon Drive half-portal on Canon Drive. The specifications of this proposal are also similar to the North Beverly Drive portal.

The North Portal project has generated interest from nearby residents and businesses, including the restaurant Spago on North Canon Drive. The restaurant has raised a number of concerns with the project, such as subway riders potentially entering Spago to use its restrooms and disrupting its business.

Doug Emhoff, Democratic Vice Presidential Nominee Sen. Kamala Harris' husband, represented the BHUSD in an unsuccessful lawsuit against the Federal Transit Administration in 2012, seeking to block tunneling beneath Beverly High.

Venable LLP, where Emhoff was a partner prior to joining DLA Piper in 2017,



proposed Constellation Boulevard Century City station was chosen based on faulty information. It also alleged that construction would disrupt campus activities and

prevent the district's plans to rehab Beverly High's campus, which is currently ongoing.

"Construction of the Constellation Boulevard subway station and tunneling underneath the campus will severely limit the use of the campus, which is a protected historic and recreational resource both for students and the public," the lawsuit

The Board of Education at the time spent several hundred thousand dollars on the lawsuit and in lobbying federal offi-

City Council Discusses Updates to Metro Station Streetscape Plans

The City Council discussed updates to the street design plans for the Metro Purple Line stations in Beverly Hills last Tuesday and established that the Traffic and Parking Commission will serve as an advisory committee to the project.

Councilmembers approved the launch of "Connect Beverly Hills," a project that is responsible for developing streetscape plan and design standards for Wilshire and La Cienega Boulevard, earlier this year. Since then, Connect Beverly Hills has conducted outreach through events and marketing to inform Beverly Hills residents about its potential plans and involve them in designing the streets.

"The intent of Connect Beverly Hills is to create attractive, welcoming and walkable corridors through placemaking that future Metro Purple Line subway riders will immediately recognize as Beverly Hills when they emerge from the two metro stations in Beverly Hills projected to open within the next five years," a city staff report written by Deputy Director of Transportation Aaron Kunz and Transportation Planner Jessie Holzer said.

City staff requested for councilmembers to recommend an advisory committee to help with its outreach, review and synthesize input from Beverly Hills stakeholders, help resolve issues and make recommendations to the City Council.

Councilmembers recommended the Traffic and Parking Commission to serve as the advisory committee, despite city staff suggesting the Planning Commission for the role.

Councilmember Julian Gold said the city would be asking a lot of the Planning Commission if it were to be the advisory committee and was skeptical it could accomplish everything on its plate.

"We know that there are several ginormous projects headed their way, hopefully in the next six months to a year," Gold said. "I don't know what their bandwidth is, but if you asked me what would I prefer to have them do, those big development projects or this? Candidly, I'd rather have them working on those development projects."

Mayor Lester Friedman said the Traffic and Parking Commission will probably have more bandwidth than the Planning Commission, but suggested it still collaborate with Planning through a liaison or ad-hoc committee.

"My suggestion for this is that the home for this be the Traffic and Parking Commission, but that there also be a liaison or an ad-hoc committee created where two members of TPC and two members of Planning can discuss issues and report back to the TPC," Friedman said.

According to a city staff report, the committee will meet at least four times before the project is completed at its anticipated date of 2021.

Councilmembers also discussed updates to the streetscape plans. According to a city staff report, Toole Design Group is responsible for completing the project.

As of last Tuesday, the group has completed a marketing and communications campaign for the streetscape plans, initial community outreach and initial existing conditions analysis for Wilshire and La Cienega Boulevard.

Its next steps are to develop streetscape and signage design standards, a draft and final streetscape plan which includes visual concepts, and programming concepts for the "Gale Mobility Hub." According to a city staff report, the city also plans to launch a second round of virtual engagement activities in August.

Beverly Hills Parks May Allow Bikes, Skateboards and More During Pandemic

Beverly Hills parks may begin to allow recreational skateboard, scooter, skate and bike riding during the pandemic, according to a Recreation and Parks Commission meeting Tuesday.

The City of Beverly Hills has traditionally prohibited human-powered land vehicles in its parks, due to safety concerns related to seniors, families and other visitors sharing the same pathways. But the COVID-19 pandemic has increased the use of parks and the desire to ride bikes, according to a city staff report.

"As people get outside more during summer and as the Pandemic persists, finding places to do solo and small group activities may put pressure on our parks to dedicate areas or provide times where these solo and smaller group activities can occur," a city staff report read.

Recreation and Parks Commissioners discussed several potential measures to take Tuesday, including allowing children to ride bikes with training wheels and adult supervision, collaborating with BHUSD schools to designate areas where children can ride bikes on weekends, modifying the park to accommodate biking or modifying streets to accommodate biking.

Director of Community Services Jenny Rogers gave some suggestions that she said could help build more of a relationship with bicyclists and those passionate about biking, which she said could help build more of a relationship with bicyclists and those passionate about biking. She said the department could then recieve more input on the kinds of things bicyclists are looking for.

"A possible place to start, especially with the engagement with youth cyclists, would be [the] department providing some programming related to bicycling. Whether that's a "Learn How To Ride Your Bike" in a small group that we socially distance

in a parking lot, whether that's at Roxbury or up at Greystone," Rogers said. "Or if we're going to have a family bike ride program, where we would have a specific route where we have families sign up and we would do that as a recreation activity."

City staff will further research potential ways to allow the use of human-powered land vehicles such as bikes and the Commission will review the item again in a future meeting.

North Maple Drive Business Receives Approval for Landscape Modifications

The Architectural Commission conditionally approved landscape modifications with an outdoor exercise area and parking wayfinding signage for a building on North Maple Drive last Wednesday.

The project applicant DFW V 331 N Maple LLC requested the commission to review and approve its proposed modifications at 331 North Maple Drive. According to a city staff report, the modifications are intended to create an outdoor green space for the office building.

Included in the proposed design was

an outdoor trellis feature, exterior lighting and an outdoor exercise area. Plants

such as common bamboo, white meadow sage and tipu trees were proposed to be planted to "soften the overall hardscape landscape."

The trellis was proposed to be made of steel and redwood beams, according to a city staff report. A half-court basketball court was proposed to be next to the trellis, which would be separated with gates and fencing.

Architectural Commission Approves 9320 Civic Center Drive Signs for Wilshire **Boulevard Building**

The Architectural Commission conditionally approved a sign accomodation for a building identification sign and ground sign for a building on Wilshire Boulevard last Wednesday.

DE Wilshire Canon, LLC applied for the review and approval of a Sign Accomodation for a Building Identification Sign and a ground sign for 9401 Wilshire Boulevard. According to a city staff report, the identification and ground sign will be illuminated in blue to identify the tenant "Ervic Cohen & Jessup."

According to a city staff report, the Beverly Hills Municipal Code allows the

commission to approve sign accommodations to allow a greater number of identification signs and approve signs to be located in areas on the building the city does not typically permit so long as it does not exceed 2% of the vertical surface area of that side.

Architectural Commission Approves Modifications to Civic Center Drive Buildings

The Architectural Commission conditionally approved facade modifications and new landscaping for two buildings on Civic Center Drive last Wednesday.

The project applicants for 9312 and

9320 Civic Center Drive are Evan Meyer and Dusan Miletich. Their proposal includes a new landscaping palette and fencing, according to a city staff report.

Elements of the proposed design included the incorporation of new trees, sandblasting one of the buildings' masonry walls and repainting it, slate grey flat-seam metal panel cladding, sandblasting the existing board-form concrete, painting dark grey stucco, installing a wood fence, installing a wood trellis system for out-

door seating and building a freestanding brick bench.



"These buildings will either be restored or refreshed to bring them in line with the proper appearance of the quaint, yet sophisticated, pedestrian scaled neighborhood that they belong to," Meyer and Miletich wrote in their application.

Subscriptions and Hosting Services Approved for **Beverly Hills Public Library**

The Beverly Hills Public Library will continue to provide online learning resources such as full-text articles, after the city renewed an agreement with an educational content, technology and services company last Tuesday.

Cengage Learning, Inc. has had an agreement with the BHPL for 20 years, according to a city staff report. The cost for renewing the agreement is \$643, 225.70, according to a city staff report.

The company provides remote access to multiple online databases, which the library has selected from for the Beverly Hills community. It is the only

vendor which publishes multi-volume reference works for schools,

public libraries and research libraries, according to a city staff report.

'During the current pandemic, remotely accessed digital resources are essential to providing the community access to up-todate resources for their personal research and educational needs," the city staff report reads.

Cengage Learning will provide its services for the next five years as a part of the agreement, according to a city staff report.

Liker Hosts Virtual Town Hall, Discusses Need for **BHUSD** to Improve

BHUSD Board of Education candidate Benjamin Liker hosted a virtual town hall Sunday, in which he answered questions and discussed his goals for the district.

Liker, a Beverly High Class of 2018 alumnus, said he wants to fix the way education in the BHUSD is conducted. He said the BHUSD has issues that he would like to address.

"It's alright to have problems [in the

district], when we have problems have to them," I fix Liker said. Among

Liker's proposed plans are more career-training for students who do plan to attend

college, improvements to sex education and properly training school nurses.

Board Approves Modular Buildings for El Rodeo

The BHUSD Board of Education ratified a lease agreement to provide three modular buildings at El Rodeo School Tuesday, which will be used for the re-

location of the Maintenance and Operations Work Space for a building in Beverly High.

The cost for the agreement is \$146,712.75, according to a board agenda. Superintendent Michael Bregy signed a lease agreement with Williams Scotsman for the buildings July 22.

El Rodeo School is currently closed for construction, which is scheduled to be completed in two years.

Writers Bloc Presents A **Livestreamed Event With** John Dean

Writers Bloc is presenting a free livestreamed event with John Dean, who wrote "Authoritarian Nightmare: Trump and His Followers" along with Bob Altemeyer, on September 1 at 5 p.m.

"Authoritarian Nightmare: Trump and His Followers," covers the reasons President Donald Trump supporters keep cheering him on. It includes explanations from The Conman Scale, developed in the 1990's and the National Survey on Authoritarianism, created in 2018.

Beverly Hills Education Association President

You were just elected to be the President of the BHEA. Why did you decide to run for the position?

I decided to run because I really do enjoy the work of BHEA and [the] collaborative conversation process [involved] in creating a positive school environment for our teachers and the students.

Tell us about your previous involvement in the BHEA.

I joined BHEA when I started teaching in Beverly Hills Unified. About five years ago, I joined the Insurance Committee and the Negotiating Committee the Bargaining Team.

What do you see as the most pressing issues the BHUSD is facing at this time, from a teacher's perspective?

Number one on everyone's mind is health and safety. We're in the middle of a pandemic so we all need to work collaboratively and proactively to ensure that whatever is coming down in the future, we're able to react to it in the best way possible.

From a teacher's perspective, shifting to online education has definitely been a harder task. [It's] more than anything than we've ever had for [the] opening of the school year. Reformatting content, delivering instruction, learning and applying new pedagogy everyday can be overwhelming. But our teaching staff has really taken that head on and is doing a great job this fall so far. So just continuing to work through those items, I think are the big ones for us right now.

At this time, those are the [issues] that are front and center on everyone's minds. So I think those [things] are probably the main focus at this time.

What have been some of the challenges associated with remote learning?

Some of the challenges include: how do you get your class to get to know each other? In the first week of school, one of the items that is very important is community building and helping the students understand how to collaborate. So creating new classroom norms that are appropriate for an online learning environment has included those kinds of challenges. There's a lot of professional development that we are undergoing and a lot of

sharing from professional to professional. What is working and what practices we want to continue in the classroom.

Has there been any training for teachers about remote learning?

Training and professional development - those are a couple terms we kind of use interchangeably. So the professional development days before the school year started, the Thursday, Friday and Monday before students joined us on Tuesday, were largely focused on learning and implementing new technologies that we can use on the online platform.

Can you name a few of those technol-

There was training on Google Classroom, which is not necessarily new but definitely being used more broadly. There were trainings on the Zoom platform, Nearpod, Seesaw and the list goes on and on

The union and district recently negotiated a new MOU for remote learning. How do teachers feel about the current plan for remote learning in the fall semester?

Remote learning, the MOU that was passed, allows for us to complete all of our instruction online. If there is a change in county health orders or any change in the Pandemic, then we will need to re-engage with the district and create a new understanding of whatever that education model would look like.

You mentioned you were on the BHEA Negotiating Committee. Can you expand on your experience in the committee and any involvement you had in negotiating the new MOU?

I was a member of the BHEA Negotiating Committee. Part of the process included completing a survey of our members with regard to topics for the MOU, then engaging with the district's team in a series of meetings to establish the agreed upon contract MOU. These meetings were productive, collaborative and involved expansive conversations over the course of several weeks.

LA County has said they might reopen schools and the BHUSD is taking steps to prepare for hybrid learning once it

meets the county's health and safety requirements. What is the union's position on returning to school?

Our union [leadership] was just placed [Monday], so we have not had meetings to form our formal statement. We need to make sure that whatever decisions are made, that health,

welfare and safety of students and staff is front of mind. The [BHUSD] Board of Education and district office personnel has also vocalized that through summer board meetings, that that is also their top priority - health, welfare and safety.

As a teacher, how do you envision in-person learning being conducted?

In-person learning would need to be a negotiated item. So our negotiating team and the district's negotiating team would sit down in a collaborative process to ensure that all party's needs are met

How do you evaluate the job Superinten-

dent Michael Bregy and the Board of **Education are doing?**

I believe that they are doing a good job. I believe that they are listening to their community [and] constituents. They are responding to staff needs and providing for BHUSD students the best possible education model that we can.

BHUSD enrollment continues to decline and is now below 3,500. How do you think the district should address this?

I am not familiar with the causes of the decline in enrollment. I'm not sure if that is necessarily due to transfers of students to other facilities or change in demographic in the community. But I think it would be a valuable course of study to understand a little bit better why there is a continued decline in student enrollment.

What made you want to teach STEM?


My undergraduate degree was in Biology and I came to BHUSD as a science teacher. When the opportunity for a new

program in STEM was presented, I think it was about seven years ago, I jumped at the chance. There's a lot of opportunities for project-based learning and it's a really exciting and motivating classroom environment.

Who have been some of your teaching

mentors in the BHU-

There are far too many to specifically name. Our profession is one that is constantly changing to meet the needs of our students. My colleagues and I continuously work together to develop, share and implement effective lessons and pedagogy in an inspiring and motivating way.



After this recent election Ethan Smith has been elected to the role of vice president and this will allow for continuous communication between us and I am looking forward to working with him.

He did advise creating boundaries on the time allotted for work, as it can be all consuming. We are doing something that's never been done before in education and we should be good to ourselves.

Did you have anything that you wanted to add or clarify for readers?

With regard to reopening schools: schools cannot reopen unless it is safe. Any decisions must be made with input from all stakeholders. These issues are very quickly evolving and changing and we will need continuous ongoing communication to ensure that health and safety is held as the top priority.

What two or three things would you like to see the BHEA accomplish a vear from now?

In a year from now, I would like to see us accomplish continued communication and collaboration with district administration. I would like to see a new certificated contract completed and to see us continue in our professional development in our training and pedagogy.

The City of Beverly Hills announced that its next round of community engagement for "Connect Beverly Hills: Meet Me on Wilshire and La Cienega" will be through a Design Elements Preference survey.

The Connect Beverly Hills project will develop a streetscape plan and design standards for Wilshire and La Cienega Boulevards to help the city prepare for the upcoming Metro Purple Line Extension that will bring two new subway stations to Beverly Hills: Wilshire/La Cienega in 2023 and Wilshire/Rodeo in 2025. These rail stations are expected to bring a significant increase in pedestrian activity along the two corridors. This project will build upon ongoing efforts to make the streets more inviting through upgraded pedestrian amenities, such as landscaping, lighting and bus shelters.

RED WAVE

Joanna Stingray discusses her new memoir on the Soviet Underground Rock Scene

You grew up in Beverly Hills and moved to the Soviet Union in the early 1980's. What made you decide to write your new book, "Red Wave: An American in the Soviet Music Underground?"

I always wanted to write a book because that tells the whole story of everything that happened. When I left Russia in 1996, there was no internet [and] no cell phones so I kind of just left. In the last four years or so, I put all my old photos up on a website and saw that the Russians went crazy over it and they

were very nostalgic. My whole life since I've been back from Russia – when people somehow get to a conversation about it or ask questions, they think it's fascinating what I got to experience. I'm just happy to share it with people and I hope they find it interesting.

How did you first get involved in the underground Soviet rock scene?

Two things happened in my life where I couldn't go to Russia, so it always was back in my mind that I wanted to go to this place. For one, my father [Sidney Fields] made a documentary film in the 1960's called "Truth About Communism" which was a propaganda film against the "evil empire" and communism. Ronald

Reagan, who was governor of California at the time, was the narrator of the film. My father growing up always told me, "Don't ever go behind the Iron Curtain, it's the evil empire." Then at [Beverly High], we had a great Russian Studies class with [the late teachers] Henry Dersch and Tom Ferris. I loved their class and they used to take kids on a one week trip at winter break to Russia. I really wanted to go, but I couldn't go because my mother [Joan Nicholas] didn't have enough money.

Fast forward to 1983, I was trying to do rock music [and] I had an [extended play] out in stores. I was trying to figure out what I was going to do with my life. I called my sister, who was going to school in London and going on a one

week trip to Russia [that] wasn't very expensive. I decided to go just to clear my head. Instead, I went and it changed my whole life.

How I met the underground rockers [was] my best friend, Diana Isaac, heard I was going [and] reminded me that her older sister, Dorothy Isaac, married a Russian immigrant. So I talked to him and he said "Oh, you're a rock and roller who's going to Russia? You have to meet my old friend, the most famous underground rocker Boris Grebenshchikov." Of course, in 1984, I laughed and didn't

believe there was any rock in Russia like all Americans. But that's how I ended up meeting Boris when I got there.

You're known for having smuggled Soviet rock music outside of the Soviet Union, during a time where music wasn't nearly as accessible as it is now. What did "smuggling" and sharing this music to the West entail?

When I came back and started talking about the rockers, everybody had my initial reaction and laughed. They couldn't believe there could be rock and roll in Russia. So then when started bringing back some cassettes with music to play or some photos, I saw how everybody was shocked and thought, "Oh my God, vou're

right. This is cool, there are rockers anywhere." I realized that I had a powerful tool to open up Americans' eyes that there was something going on behind the Iron Curtain that we could relate to [and] think is interesting.

That's when I decided to put out a double album [Red Wave] of four bands [Aquarium, Kino, Alisa and Strange Games.] Because it was the first time Americans had heard or saw Russian rock, I wanted to give them at least more than one band. It took about a year to smuggle everything out and I just had to figure out ways [to do it]. I had some boots that I used to wear during the winters in Russia and I figured out I can take out my insole [to] put all the Russian lyrics in there that I wanted to be albumed.

I had a big leather jacket that had zippers everywhere. I did have a little bit of help from a couple of Western consulates that were in Leningrad at the time – the Swedish consulate [and] the French consulate that helped me get a couple things out.

The album [in the United States] was put out on Big Time Records, which was a small Australian label. I had met with some of the big record labels, Warner Brothers and some of the other ones, and they all liked the music but they were afraid of the legality side. I said they were underground rockers, so they own their own music but they were [still] nervous about it.



Back in the day, the [United States] consulate, Swedish consulate [and] French consulate used to invite Boris and some of the rockers to come over to party and watch some Western films. They had found out about the bands and really liked them, so they would invite them over to eat and stuff. I was invited to some of those parties and made friends with some of these Western consulate people. A few of them helped [smuggle music] in a couple ways.

As someone who is not Russian or from the Soviet Union, why did you involve yourself so heavily in popularizing Russian and Soviet music and culture?


Three out of four of my grandparents were from Russia, the former Soviet Union. I just went to clear my head for a week, but I was so taken by what I heard and saw. I just got passionate about going there and being part of it. The scene in Leningrad – the rock scene [and] the art scene in the 1980's were very similar to what was going on in Laurel Canyon here in the 1960's with rock music. All the bands being creative, sharing and working together – that's the vibe of what was going on in Leningrad. So for me, it was magical. I just wanted to be there, be part of it and help them.


You spent almost a decade living in Russia. What was that experience like?

I went there on and off for 12 years. In the beginning, it was hard to be [in Russia] for more than a week at a time. It was not easy to get into the Soviet Union under communism. But I went every three months for a week and parts of it was like being in an old-fashioned movie. A lot of things, the apartments [for example], were warm and friendly but the furniture and everything was outdated. It was definitely a different way of life. It was very cold, very unlike what I was used to in Los Angeles.

Being in a communist country, it's certainly scary. You feel like you're being followed. Many times when we were guests at somebody's apartment, when we left, the KGB came and questioned them. I was followed when I had a renta-car a couple times, by a car behind

me. I was pulled over for traffic violations I didn't do. Some parts of it were scary but what went on behind doors in those days under communism was just vibrant. It was very much like anywhere in the world. Who wouldn't want to be part of it?






I ended up becoming an enemy of the Russian state and couldn't get married to my first husband, Yuri Kasparyan. I couldn't get a visa and couldn't get in, which ruined my whole life. But before that, I was contacted and questioned twice by the FBI in a roundabout way and then again by the KGB in a roundabout way. What I learned from those meetings is that the KGB and the FBI seemed like they were trained at the exact same school.

They don't come out and ask you what they're there for. They really just wanted to say, "Are you a spy?" But they don't ask that. They do all these intricate circular questions, "Have you done this?" [and] "Have you met this?" It just baffled me how similar they seemed and how they also seemed to have tunnel vision. When they saw an American girl going in and out of Russia every three months, they just couldn't see past that being for any other reason than being a spy. It was very hard for me to convince them that I wasn't a spy, which was a little bit frustrating. And then to actually become an enemy of the Russian state and not be able to see my friends or get married was

I was supposed to get married in February of 1987. There were a whole bunch of us going: my sisters, my mother [and] some friends. Life magazine was going to come [and] NBC News wanted to film the wedding. But three days before the trip, the travel agent called and said that one visa was declined [which] was mine. I flipped out and called the Soviet Embassy in Washington D.C. [I] was telling the guy my story – I was all riled up and pretty hysterical. He said "Don't worry, I'm sure it's just a mistake. Give me 10 minutes, call me back."

So I calmed down for a second, think-

ing it'll be fixed. I called him back in 10 minutes and his voice [had] completely changed. He said "No visa. A telegraph came from Moscow that said, 'Moscow

is not expecting Joanna Stingray." Then he hung up on me. For me, what's interesting about that is my name was not legally Joanna Stingray at that time. My visa was under my real name, Joanna Fields, so the fact that they sent back a tele-x [saying that] was them letting me know that they are mad at me and they didn't appreciate me putting out the Red Wave [album].

Where does the name "Stingray" originate from?

I decided to put the record together with Boris and the two of us were figuring out how to do it. In those days, there was no email [and] no cell phone. So we had to try to call on the phone and quite often the phone would be disconnected

because either the KGB or the FBI were listening on the phone. But definitely on the Soviet side, they would disconnect the phone. We couldn't talk straightforward of what we were doing, so we de-

cided we better come up with codenames.

Boris' codename was Jagger. I couldn't think of a codename [for me] for a while. But I was actually with my [Beverly High] friend Paul Gomberg in his Corvette Stingray, driving from Houston, Texas to Bloomington, Indiana. I was telling him how I had to come up with a codename and I looked up to my feet that were on the dashboard and it said

Stingray. So that became my codename and then we had codenames for all the bands. When I did call and we could talk for a minute before the line was cut I'd say, "Did Jagger get the lyrics for the Duran Duran band?" as if we were talking about something else.

Your daughter Madison, who goes by the stage name Stingray and co-wrote this book with you, is also pursuing music. Tell us about that.

She's a songwriter and she's record-

ed songs since she was about 12 years old. But she never felt comfortable releasing any of them. She did release an album, "In Your Eyes," not long ago and she also wrote a couple of songs.

You produced several albums and singles throughout your career, including "Beverly Hills Brat," "Red Wave" and "Shades of Yellow." Which of your projects would you say was your favorite and why?

My favorite album is "Shades of Yellow." I think that was my best lyric writing. My daughter's dad, Sasha Vasilyev, did the music for it and I did the lyrics. I actually just released a song that's out now, called "Love Is No Joke." I sing in English and Russian on the chorus.

I [also] just got a record deal in Russia – they want to release a bunch of my archival songs that were never released before. I should have some new releases coming up, but of the ones that are out

now "Shades of Yellow" is my favorite.

What do you hope readers will take away from your book?

I hope readers get a sense of what was going on behind the Iron Curtain beside what they've seen in the days of the politics and the coldness. I hope I give them a glimpse of how similar the Russians were to us and how exciting and fulfilling

their lives were even under communism. I hope they also get from the book the power of music and the power of expressing yourself through art.






